Report Items:

1. The Board will receive the Good News Report highlights of the last month.
2. Mr. Alderson will provide the elementary end-of-the-year discipline report.
3. Mr. Lurz will provide the high school end-of-the-year discipline report and summarize the first week of the high school summer school program.
4. Mr. Alderson will summarize the first week community free lunch program hosted by the district. Annually districts are required to review the district's bullying policy, as well as provide an annual report on the drug free status of the district. Mr. Witt will facilitate this reporting. Mr. Lurz will provide a report on the multi-cultural activities of the district during the 2016-17 school year. Mr. Witt will provide information on the certified staff assignments for 2017-18 as well as the coaching/sponsorship assignments. Mr. Witt will conclude the District Reports section of the agenda by facilitating a discussion of Operating Principle Six.
5. NASB will coordinate an Open Meeting Law Workshop on July 13th from 6:30 to 8:30 p.m. at the Kearney High School. Nebraska law requires that all public bodies comply with the Open Meetings Act, which includes detailed requirements regarding Notices of Meetings, Agendas, Minutes, Closed Sessions, Special and Emergency Meetings and Public Comment. Matthew Dunning, NASB's Legal Counsel and members of the Nebraska Council of School Attorneys will conduct this workshop, including an interactive analysis of factual scenarios based on Attorney General disposition letters and questions received by the NASB. Questions and discussion are encouraged! Board members interested in attending should contact Mr. Witt by the end of the day on Thursday, June 29th.
6. Mr. Green attended the School Law Workshop on June 9th. He will provide some highlights of his attendance. Mr. Witt and members of the Facility Committee will provide information on the district's status with the OCR and the approved remediation plans as well as other ongoing and planned projects.

Discussion Items:

1. Mr. Alderson and Mr. Witt will summarize information gathered regarding the potential of the district contracting the district food services beginning with the 2017-18 school year.
2. The district has been cooping with KCHS the past two years in the boys' and girls' soccer program. The Board will be asked to consider the signing of a second, two-year agreement.
3. The Coaches' and Sponsors' Handbook has numerous revisions. The majority of these come in section 27 (Lettering Requirements). The intent of changes in the lettering requirements is to encourage students to become involved in a wider variety of school sponsored activities. There is also a proposed change to section 39 (School Colors).
